

# MICHIGAN MASTERS SWIMMING Summer Newsletter - 2011

### BATTLE CREEK WINS 1ST LARGE TEAM STATE CHAMPIONSHIP

2011 marked the occasion of the 39<sup>th</sup> Annual Michigan Masters State Championships. 344 swimmers turned up at the Kentwood Community Aquatic Natatorium from April 15 to April 17 to participate in the traditional event.

The Battle Creek YMCA won their first Large Team Combined Championship in their team history after winning 6 Small Team Combined Championships in 1994, 2000, 2001, 2002, 2004, and 2007. Battle Creek won both the Large Team Women's and Men's Championship category as well. Dutch Masters won the Small Team Combined, Men, and Women's Championships. It was their second Small Team Combined Championship to go along with 3 Large Team Championships won in 2001, 2003, and 2007.

Twenty four LMSC State Records (1 Women, 20 Men, and 3 Relays) were set during the course of the meet. There were 52 State Championship Meet Records (19 Women, 33 Men, and 10 Relays) set during the course of the meet. Results, Records, and High Point Awards are included in the results exhibits on the Michigan Masters website.

The highlight of the meet was the USMS National

Record that was set by Larry Day in the 100 Fly swimming in the 60-64 age group. He swam a time of 2:10.06 which broke the previous National Record of 2:11.69 set back in 2004. This was Larry's third USMS National Record in USMS with the others set in 2001 in the 100 and 200 meter Fly. Those swims were also FINA World Records at that time. This is the 5<sup>th</sup> year in a row that a USMS National Record has been set at the State Meet Championship.

On the Men's side, Larry Day set 6 Championship and 6 State Records and he was the only swimmer at the meet who accomplished this. Kevin Doak set 4 Championship and 4 State Records. Paul Karas set 6 Championship and 2 State Records, Frank Cody set 3 Championship and 2 State Records, Mark VanderMey set 3 Championship and 2 State Records, John Alt set 2 Championship and 2 State Records, and Ken Cooper set 2 Championship Records. The rest of the single male swim records are listed in the Records and Awards Summary.

On the Women's side, Sally Guthrie was the only swimmer to set a State Record and that was in the 50 Back and additionally set

5 Championship Records. Lois Kivi Nochman was the only swimmer in the meet to set 7 Championship Records in all of the events she entered. Corrin Popps swam to 2 Championship Meet Records. The rest of

the single female Championship Records are listed in the Records and Awards Summary.

A big thank you goes out to Meet Directors Jock Ambrose and Mark Spore for their service accommodating all of the distance swimmers with the extra pool space when entries were higher than expected and everything else that goes into running a successful State Championship Meet. Another big thank you goes out to East Kentwood HS swim teams, the Kentwood Aquatic Club, the Officials for running an excellent meet during the long hours of the three day competition, and the 345 swimmers that showed up and swam.
